Bottom line: If you are serious and interested, then register now.

Secure your place, and pay the registration fee, which is not refundable. 90 days before the course, pay the course fees in full. This includes everything except travel and dinner costs. If you do not want to stay in the hotel, pay the full fee less the hotel costs provided.

## **REGISTRATION POLICIES:** Please read these terms and conditions carefully.

**LIABILITY WAIVER:** Participation in this course will require travel to and from the course location. You agree that you are aware of the risks of travel and further that you assume all risks of travel and attendance.

**PAYMENT:** The Registration fee is due up front at time of registration. 90 days before the course the remaining fees are due and payable and include applicable taxes. Unless otherwise indicated, fees do not include participant travel costs, evening meals or other living expenses. Payment is accepted via Credit Card via PayPal payments. Once payment is received, an email will be issued confirming the registrant's seat in the course. We are arranging the hotel venue and all of participants' hotel accommodations reservation and payment.

**REGISTRATION:** We need sufficient lead time for our course logistics. LTRO would appreciate receiving registrations at least three months before the course. Registrations can be made online at link provided or by contacting Gil.Arnon@LTRO.com. Registrations are confirmed upon receipt of payment. Acknowledgment of Reservations will be issued via email. ## TUITION FEES: Tuition fees include:
